

PRECAUTIONARY STATEMENT

1.Photo Plan Precautionary Statement

(1) [General]

- a.** Shooting locations may be modified due to weather issues.
- b.** Shootings may be cancelled or dates may be modified at the discretion of our company, due to weather issues, or other various reasons. In the event of a cancellation, a refund will be issued for those services. However, in the event of a cancellation made by the customer, there will be a Cancellation Fee.
- c.** Regarding the inclusive basic dress and tuxedo, if the cost of the chosen dress/tuxedo exceeds the value included in the plan, the customer is responsible for the difference in price. If the customer is renting them at the local salon, they must submit their payment there. If the customer has had a fitting at a Watabe Wedding Dress Salon, they must submit their payment there. However, if the cost of the chosen dress/tuxedo is below the value included in the plan, a refund will not be applicable.
- d.** Custom-sized dresses/tuxedoes are not available.
- e.** For an upgrade of the included accessories, additional fees will apply. Retail products (stockings, socks, undergarments, etc.) are not included in the plan.
- f.** All shooting of footage is completely at the discretion of our photographers. Photo Shoot location cannot be designated.
- g.** Children 6 years or younger, may not be accompanied unescorted. Our staff is prohibited to babysit.
- h.** For photo shootings in hotels, beaches, and parks, there may be instances where it is largely crowded with people.
- i.** Please notify the assigned stylist of any requests, during the beauty service. We are not responsible for any requests after the service is done.
- j.** It is customary to give a monetary tip (to the Stylist, Photographer, Videographer, Driver), if you felt the service was satisfactory or better.

- k. By regulation, guests are not allowed to attend the Photo Plan with the couple.
- l. The transportation included in the plan is only for the couple.
- m. Our company strictly prohibits the use of any undesignated external contractors for photography or video recording.
- n. Additional albums will be created in the same form as the initial order album.

(2) [Hawaii]

- a. For Oahu, the fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after at the Waikiki Salon.
- b. Please return all rental garments to the Bell Desk of your hotel, by that same day.
- c. If payments will be done locally, the following payment methods are acceptable: Cash (U.S. Dollar), or Credit Card (VISA, Mastercard, JCB).
- d. Local Sales Tax will be added (Oahu: 4.712%, Hawaii (Big Island): 4.166%).
- e. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.

(3) [Guam/Saipan]

- a. The fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the local salon branch.
- b. Please return all rental garments to the Bell Desk of your hotel, by that same day.
- c. If payments will be done locally, the following payment methods are acceptable: Cash (U.S. Dollar), or Credit Card (VISA, Mastercard, JCB).
- d. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.

(4) [Australia]

- a. The fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the local salon branch.
- b. If payments will be done locally, the following payment methods are acceptable: Cash (AUS Dollar), or Credit Card (VISA, Mastercard, JCB, American Express).

- c. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.

(5) [Tahiti]

- a. For Tahiti, the fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the hotel room or the local salon.
- b. The Bora Bora Photo Plan is subjected only to customers who are able to visit the Watabe Wedding Tahiti Branch Store, and pick up their rental garments.
- c. The required time duration at the Watabe Wedding Tahiti Branch Store is approximately 2-2.5 hours, and the transit time from Pape'ete to Bora Bora will be over 4 hours.
- d. All rental garments and accessories must be personally carried to Bora Bora. The luggage weight limit for domestic flights is 40kg (approx. 88 lbs.) for 2 people, so we recommend that you should limit your own luggage to approximately 30kg (approx. 66 lbs).
- e. All rental garments and accessories will be collected by the assistant, after the photo shoot is completed.
- f. For the Bora Bora Exclusive canoe photo shoot, boarding the canoe may not be permitted due to weather issues, but the photo shoot will be conducted around the canoe area. If this should occur, please be advised that a refund will not be applicable.
- g. Please be advised that if the photo shoot date should fall on a local holiday, we will not be able to accept any upgrade orders for fresh flower bouquets and/or headpiece arrangements.
- h. If payments will be done locally, the following payment methods are acceptable: Cash (French Pacific Francs), or Credit Card (VISA, Mastercard, American Express).
- i. Photo Data and Albums (including Additional Albums) will be delivered approximately 40 days after photo shoot date.

(6) [Las Vegas]

- a. The fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the Las Vegas Branch Store.
- b. If payments will be done locally, the following payment methods are acceptable: Cash (U.S. Dollar), or Credit Card (VISA, Mastercard, JCB).

- c. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.

(7) [Paris/Firenze(Florence)]

- a. The fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the local salon branch.
- b. The transportation included in the plan is only for the couple. At times, the photographer and/or the attending staff may ride in the same vehicle.
- c. Children 12 years or younger, may not be accompanied unescorted. Our staff is prohibited to babysit.
- d. If payments will be done locally, the following payment methods are acceptable: Cash (Euro), or Credit Card (VISA, Mastercard, JCB, Paris only: American Express).
- e. Photo Data and Albums (including Additional Albums) will be delivered approximately 40 days after photo shoot date.

(8) [Bali]

- a. The fitting will be conducted on the day of the photo shoot, and the Bride's hair/make-up will be conducted after, at the Bali Branch Store.
- b. If payments will be done locally, the following payment methods are acceptable: Cash (Indonesian Rupiah), or Credit Card (VISA, Mastercard, JCB).
- c. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date. *The Photo Data included in the Basic Plan will be delivered to the hotel 2 days after the photo shoot date.

(9) [Okinawa]

- a. The 8% Sales Tax is included in the price shown.
- b. The fitting will be conducted on your arrival day, and the Bride's hair/make-up will be conducted on the day of the photo shoot, at the local salon or the local store.
- c. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.
- d. Children 6 years or younger, may not be accompanied unescorted. Our staff is prohibited to babysit. Please order the Babysitter Service, if you do not have any guests attending. When the Babysitter Service is ordered, you must

complete a Consent Form. If there are 2 children, please order 2 babysitters for safety purposes.

- e. Round-trip transportation to and from the photo shoot location is not included for the Yomitan Village/Ishigakishima Island Beachside Photo Plan.
- f. Photo Shoot location cannot be designated.
- g. Beach shooting locations may be modified (such as, indoors, etc.) due to weather issues, or other various reasons.

(10)[Hokkaido]

- a. The 8% Sales Tax is included in the price shown.
- b. If garments are rented locally, by regulation the fitting is conducted on the day of the photo shoot, but there may be times it will be conducted on the day before.
- c. The Bride's hair/make-up will be conducted at the chapel salon.
- d. Photo Data and Albums (including Additional Albums) will be delivered approximately 30 days after photo shoot date.
- e. If special floral materials are requested for the fresh bouquet upgrade, a separate estimate is necessary.
- f. All unauthorized photographers/videographers (including filmings by guests) are strictly prohibited.
- g. Transportation Service for briefing, outfit selection, or issuing of optional items, is not available.

(11)[Kyoto Wakon]

- a. Photo Shooting Plans can be arranged for Weekdays only; no Weekends are available.
- b. The Photo Shooting date and/or time may be modified due to weather issues.
- c. Briefing, fitting, and the hair/makeup services will be conducted at Watabe Wedding Kyoto Main Branch. Please arrange for your own transportation to the Kyoto Main Branch.
- d. Please be responsible for the safekeeping of your valuables, or you may use the lockers in our showroom.

- e. You may pay for your optional items at the Kyoto Main Branch. Acceptable payment methods are: Cash (Japanese Yen only) or Credit Card.
- f. For attendants who wish to accompany you on your photo shoot, transportation can be arranged for an additional fee.
- g. A taxi can be ordered for your transportation from the hotel to the Kyoto Main Branch. (You are responsible for the taxi fare.)
- h. The Photo Data will be delivered to your mailing address approximately 30 days after the photo shoot date.
- i. In the event that you arrange for your own photographer, there will be an additional service charge.
- j. The Groom should be prepared with a low-neck T-shirt or V-neck shirt (For the Rental Attire Plan only).
